### Hazard Statements

**Emergency Action:** Keep unnecessary people away; isolate hazard area and deny entry. Stay upwind; keep out of low areas. Positive pressure self-contained breathing apparatus (SCBA) and structural firefighters protective clothing will provide limited protection. If water pollution occurs, notify the appropriate authorities.

**Fire:** Some of these materials may react violently with water.

**Small Fires:** Dry chemical, CO<sub>2</sub>, water spray or regular foam. Some of these materials may react violently with water.

**Large Fires:** Water spray, fog or regular foam. Move container from fire area if you can do it without risk. Apply cooling water to sides of containers that are exposed to flames until well after fire is out. Stay away from end of tanks. Do not scatter spilled material with high-pressure water streams. Dike fire control water for later disposal.

**Spill or Leak:** Do not touch or walk through spilled material; stop leak if you can do it without risk. **Small Spills:** Take up with sand or other noncombustible absorbent material and place into containers for later disposal. **Small Dry Spills:** With clean shovel place material into clean, dry container and cover loosely; move containers from spill area.

**Large Spills:** Dike far ahead of liquid spill for later disposal.

**First Aid:** Move victim to fresh air; call emergency medical care. In case of contact with material, immediately flush skin or eyes with running water for at least 15 minutes. Remove and isolate contaminated clothing and shoes at the site. Keep victim quiet and maintain normal body temperatures.
